CREDIT AGREEMENT

The undersigned ('Customer') hereby agrees to credit terms of _____. Display Products Incorporated reserves the right to add finance charges to the Customer's account at a rate of 1.5% per month, calculated on any amount more than 30 days past due, until said amount is paid. In the event that it is necessary to institute collection proceedings to recover amounts due from Customer, Customer hereby agrees to pay any and all costs of such proceedings, including, but not limited to attorney fees, court costs and fees for collection. If any litigation for non payment of goods and services is required, said litigation will be filed in Dallas, Texas. If the Customer's account goes 60 days past due twice within six months, the Customer's credit line may be forfeited and placed on COD status for a minimum of 6 months. Display Products reserves the right to place the Customer's account on prepaid or COD status at any time without prior notification to the Customer. If the Customer's account remains inactive for 12 consecutive months or ownership of the company changes, a new application and agreement will be required.

Due to the custom nature of our product line, we require a minimum of 50% down on all custom orders. COD orders greater than \$5,000 will require certified funds.
